

**RESOLUTION OF THE BOROUGH OF LAVALLETTE
LAVALLETTE, STATE OF NEW JERSEY, AMENDING FEES AND RATES
FOR THE TOWING AND STORAGE OF MOTOR VEHICLES**

WHEREAS, Chapter 60A of the Code of the Borough of Lavallette entitled, “Towing and Storage” establishes rules and regulations, pursuant to N.J.S.A. 40:48-2.49 et seq., for the towing and storage of motor vehicles from public roadways by operators engaged in the business of towing and storing of motor vehicles; and

WHEREAS, 60A-6 entitled “Rates and Fees” requires that the fees and rates for the towing and storage of motor vehicles be established by resolution of the Mayor and Borough Council, which rates shall be based on the usual, customary and reasonable rates of operators towing and storing motor vehicles in the Borough; and

WHEREAS, the Chief of Police has recommended a rate and fee scheduled to be adopted by the Mayor and Council.

NOW, THEREFORE, BE IT RESOLVED by Mayor and Council of the Borough of Lavallette, County of Ocean, State of New Jersey, that the following rate and fee schedule, as recommended by the Chief of Police, is hereby approved as follows:

Towing Rates:

The following are the towing rates for all dispatched calls for service as amended:

A. Class I vehicles (GVWR 8,600 pounds or under):

1. Tow: from scene to shop or location within tow zone of call: ~~\$125.00~~ \$150.00

2. Storage:

a. Outside storage rate: \$35.00 per calendar day

b. Inside storage rate: \$45.00 per calendar day

B. Class II Vehicles (GVWR 8,601 pounds):

1. Tow: from scene to shop or location within tow zone of call: ~~\$155~~ \$200

2. Storage:

a. Outside storage rate: \$45.00 per calendar day

b. Inside storage rate: \$55.00 per calendar day

C. Class III Vehicles (GVWR 15,000 pounds and above):

1. Tow: from scene to shop or location within the tow zone of call: ~~\$250~~ \$350
2. Storage:
 - a. Outside storage rate: ~~\$70.00~~ \$75.00 per calendar day
 - b. Inside storage rate: ~~\$80.00~~ \$125.00 per calendar day

D. Motorcycles, ATV's, and Dirt Bikes:

1. Tow: from scene to shop or location within the tow zone of call: ~~\$125~~ \$150
2. Storage:
 - a. Outside storage rate: \$35.00 per calendar day
 - b. Inside storage rate: \$45.00 per calendar day

E. Miscellaneous:

1. Administrative fee after 1 day of vehicle's arrival to the yard: \$25.00 and must provide documentation of administrative services provided.
2. Debris cleanup is mandatory (see N.J.S.A. 39:4-56.8). If debris cleanup is excessive and requires 20 minutes or more to remove, a one-time fee of ~~\$25.00~~ \$35.00 is permitted.
3. Additional truck/personnel: \$80.00 per hour
4. Off road recovery/winchng to include up righting a rolled vehicle; to be billed in 30 minute increments:
 - a. Class I Vehicles: \$120.00 per hour
 - b. Class II Vehicles: \$150.00 per hour
 - c. Class III Vehicles: \$225.00 per hour
5. Dolly fee: \$50.00
